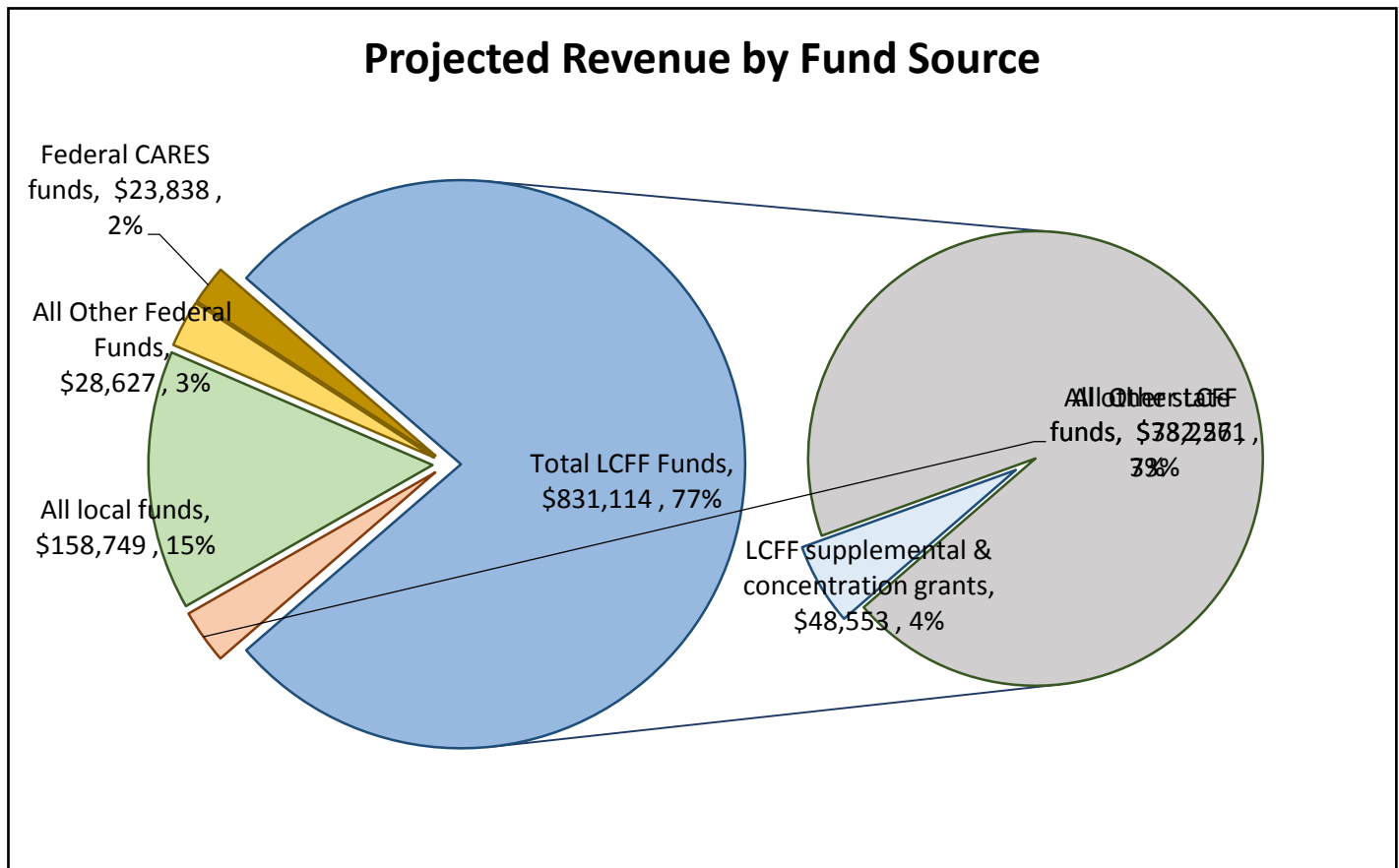

School districts receive funding from different sources: state funds under the Local Control Funding Formula (LCFF), other state funds, local funds, and federal funds. LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).

### Projected Revenue by Fund Source

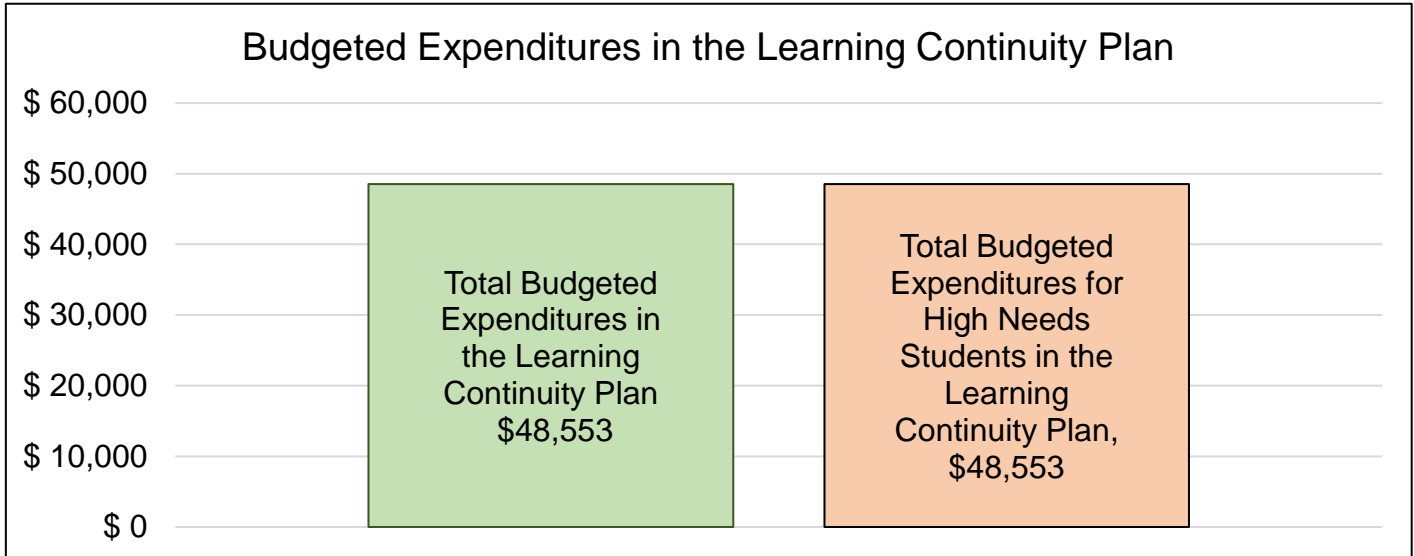


This chart shows the total general purpose revenue Big Sur Unified School District expects to receive in the coming year from all sources.

The total revenue projected for Big Sur Unified School District is \$1,075,555.00, of which \$831,114.00 is Local Control Funding Formula (LCFF) funds, \$33,227.00 is other state funds, \$158,749.00 is local funds, and \$52,465.00 is federal funds. Of the \$52,465.00 in federal funds, \$23,838.00 are federal CARES Act funds. Of the \$831,114.00 in LCFF Funds, \$48,553.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

# LCFF Budget Overview for Parents

For the 2020-21 school year school districts must work with parents, educators, students, and the community to develop a Learning Continuity and Attendance Plan (Learning Continuity Plan). The Learning Continuity Plan replaces the Local Control and Accountability Plan (LCAP) for the 2020–21 school year and provides school districts with the opportunity to describe how they are planning to provide a high-quality education, social-emotional supports, and nutrition to their students during the COVID-19 pandemic.



This chart provides a quick summary of how much Big Sur Unified School District plans to spend for planned actions and services in the Learning Continuity Plan for 2020-2021 and how much of the total is tied to increasing or improving services for high needs students.

Big Sur Unified School District plans to spend \$1,067,561.00 for the 2020-2021 school year. Of that amount, \$48,553.00 is tied to actions/services in the Learning Continuity Plan and \$1,019,008.00 is not included in the Learning Continuity Plan. The budgeted expenditures that are not included in the Learning Continuity Plan will be used for the following:

Items not listed in the Learning Continuity Plan are general instructional expenditures such as teachers, inst. Aides and instructional materials and contracts. Support expenditures include administrative and clerical support, maintenance costs, custodial costs and operational costs such as utilities. Expenditures also include restricted grants and entitlements such as SPED, REAP, Covid, lottery and local programs.

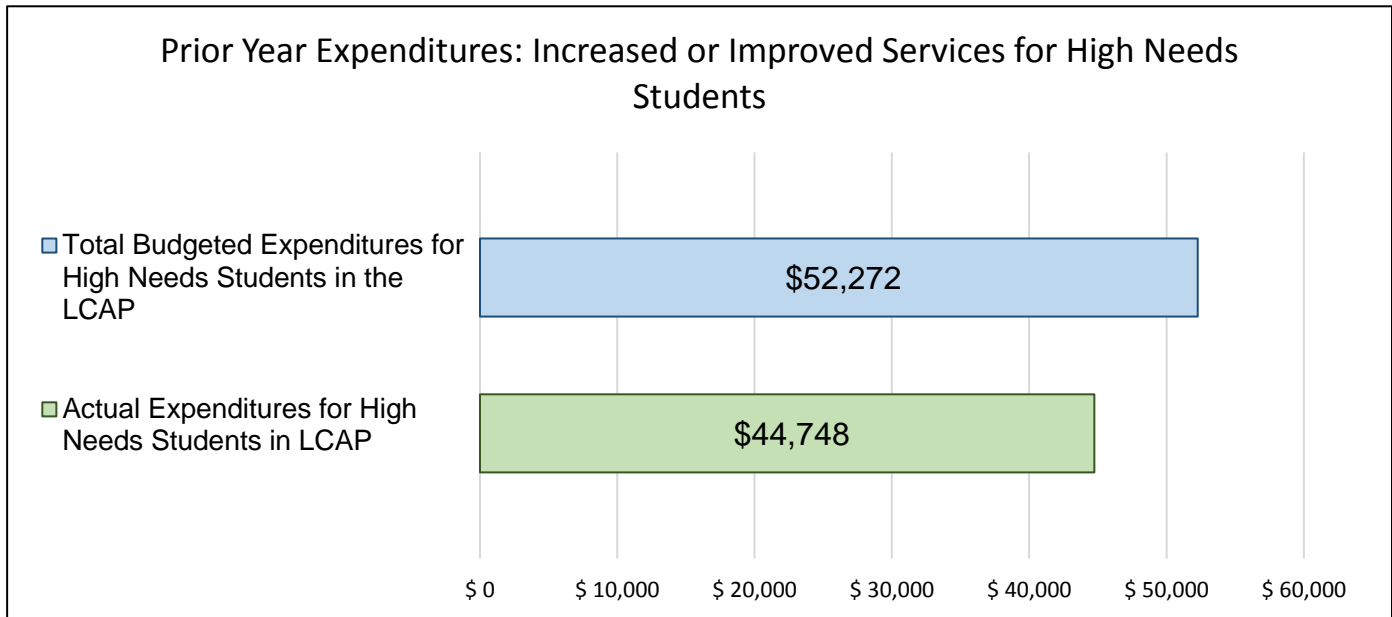

## Update on Increased or Improved Services for High Needs Students in 2019-2020



This chart compares what Big Sur Unified School District budgeted in the 2019-20 LCAP for actions and services that contributed to increasing or improving services for high needs students with what Big Sur Unified School District actually spent on actions and services that contributed to increasing or improving services for high needs students in the 2019-20 school year.

In 2019-2020, Big Sur Unified School District's LCAP budgeted \$52,272.00 for planned actions to increase or improve services for high needs students. Big Sur Unified School District actually spent \$44,748.00 for actions to increase or improve services for high needs students in 2019-2020. The difference between the budgeted and actual expenditures of \$7,524.00 had the following impact on Big Sur Unified School District's ability to increase or improve services for high needs students:
